

Expression of Interest (Eoi)

Haryana State Rural Livelihoods Mission (HSRLM)

Invites proposal for Hiring of agency who wish to undertake an "Evaluation of Start-up Village Entrepreneurship Programme (SVEP)", a sub-scheme implemented under Deendayal Antyodaya Yojana (DAY-NRLM) by the HSRLM under Rural Development Department, Government of Haryana.

Deendayal Antyodaya Yojana-National Rural Livelihoods Mission (DAY-NRLM) is a centrally sponsored programme implemented since May 2013. The main objective of the Mission is to eliminate rural poverty through innovative implementation strategies involving four core components viz., (i) social mobilization and community institution building; (ii) financial inclusion; (iii) livelihoods promotion; and (iv) convergence and social development.

Start-up Village Entrepreneurship Programme (SVEP) is a budget announced scheme and was approved by the Hon. Minister RD, Gol on May 6th, 2015 as a sub-scheme under the DAY – NRLM and the guidelines were issued on 15th June 2015. The objective of SVEP is to help the rural poor come out of poverty by helping them set up enterprises and provide support till the enterprises stabilize. It focuses on providing sustainable livelihoods and self-employment opportunities with financial assistance and training in business management of soft skills while creating local community cadre for promotion of enterprises.

HSRLM is the implementing agency in Haryana State for achieving those objectives. The programme has led to promote 1643 enterprises in Bhiwani and 1343 enterprises in Nuh and create employment for 2986 rural poor in four years from 2016. All enterprises will be targeted for evaluation purpose.

Selection Procedure:

One agency will be selected for one block.

The selection of agency will be on the basis of Quality and Cost Based Selection Method (QCBS).

The intending parties will submit their proposals on format Annexure-1 & 2 till **21st March, 2022** at the Office of Chief Executive Officer (CEO), Haryana State Rural Livelihoods Mission, SCO-19, Sector-16, Panchkula by **04:00 P.M.** The bid shall be submitted in two parts viz **Technical Bid and Financial Bid in separate envelop.** Detailed terms & conditions of tender documents can be downloaded from the HSRLM website www.hsrlm.gov.in.
