

Invitation for submission of Project Proposals under DDU-GKY

Haryana State Rural Livelihood Mission (HSRLM) invites proposals under Deen Dayal Upadhyaya - Grameen Kaushalya Yojana (DDU-GKY) from the Project Implementing Agencies (PIA) having Permanent Registration Number (PRN) obtained from the Ministry of Rural Development (MoRD) for implementation in the state of Haryana. Interested PIAs may submit their proposal online at www.ruralskills.in. For the year 2017-19 we have training target of 11,000. While preparing the proposal, revised CNN (Cost Norm Notification) is to be taken into account as per MoRD Notification No. 25/2016, dated 4th May 2016. Training programmers shall be completely residential and for a duration of preferably 6 (six) months, as detailed in Programme Guidelines of DDU-GKY issued in July, 2016. The PIA will have to pay an application fee of Rs. 25,000/- through NEFT/ RTGS to the bank A/C of DDU-GKY, HSRLM as per the particulars given below:

Incomplete proposals shall be summarily rejected. Subsequent to the online submission, soft copy (in PDF format) should be emailed to ceohsrlm@gmail.com within 2 (Two) days of submission of the proposal online. Hard copy of the proposal should be sent along with a complete set of supporting documents in secured envelope addressed to The Chief Executive Officer, Haryana State Rural Livelihood Mission, Akshya Urja Bhawan, Institutional Plot no. 1, Sector-17, Panchkula. The envelope should be superscripted with 'DDU-GKY Project Proposal'. Hard copies of proposals should reach this office within 10 (Ten) days of submitting the proposal online.
