

## Expression of Interest (Eoi)

### Haryana State Rural Livelihoods Mission (HSRLM)

Invites proposal for Hiring of Resource Agency/ individuals for Capacity Building (trainings) of women of Self Help Groups, women of Village Organisations (VOs) & Cluster Level Federations (CLFs) and HSRLM staff at the District, Block and village levels across the 22 Districts of Haryana.

In Haryana, HSRLM has 3-tier setup i.e., SMMU (State Mission Management Unit) at the State level, District Mission Management Units (DMMUs) at District level, Block Mission Management Units (BMMUs) at Block level. There is Community Based Organisations (CBOs) also like SHGs/VOs at village level and CLFs at Block level.

Sub Schemes of DAY-NRLM are as under:

1. Start-up Village Entrepreneurship Programme (SVEP) in selected Districts
2. Mahila Kisan Sashaktikaran Pariyojana (MKSP) in selected Districts
3. Aajeevika Grameen Express Yojana (AGEY) in all Districts

Currently 46,177 SHGs, 2921 VO's and 130 CLFs in which 4,93,402 Households have been covered in 142 Blocks of 22 Districts in the state of Haryana. The key objective of HSRLM is to reduce poverty of rural poor women by supporting income generation activities and their empowerment.

HSRLM requires well versed Agencies/individuals with minimum of 10 years of experience in the field of Capacity Building (training) of rural communities to undertake the following works:-

- Training Needs Assessment, capacity development of SHGs, VO's, CLFs and mission staff at District, Block and cluster level, develop training modules, training Kits, IEC material etc.
- Exposure visits of women for development of greater vision and perspective towards planning and running Income Generation Activities (IGA) and enterprise development.
- Establishment of successful market linkages with major market players.
- Linkage of project beneficiaries with various government schemes for skill development, productivity enhancement, infrastructure support, raw material procurements etc.

#### Selection Procedure:

The selection of agency/individual will be on the basis of Quality and Cost Based Selection Method (QCBS).

The intending parties will submit their proposals on format Annexure-1/2 till 20<sup>th</sup> September, 2021 at the Office of Chief Executive Officer (CEO), Haryana State Rural Livelihoods Mission, SCO-19, Sector-16, Panchkula by 04:00 P.M. The bid shall be submitted in two parts viz Technical Bid and Financial Bid in separate envelop. **Detailed terms & conditions of tender documents can be downloaded from the HSRLM website [www.hsrlm.co.in](http://www.hsrlm.co.in)**


