The Committee took note of the absence of representative from Department of Technical Education, Haryana; and Department of Skill Development & Industrial Training, Haryana.


Agenda No. 12.2 Confirmation of the minutes of 11th PAC meeting held on 10th December’ 2021

Agenda No. 12.3 Action Taken Report on the Minutes of the Previous 11th PAC meeting

The Chairman PAC and all members were apprised about the status of PIAs which were approved in the 11th PAC meeting.

Out of 26 approved projects in the 11th PAC, 23 PIAs have submitted the revised proposal on ERP Portal and are under verification by HSRLM.



Three PIAs viz. (i) AITMC Ventures Pvt. Ltd., (ii) Rozgar Vikas Education Private Ltd & (iii) Arshya Education Pvt Ltd have represented their case for cancellation/change in project parameters which are mentioned as below:

Therefore, the PIA has requested to approve an additional trade - CRM Domestic Voice (SSC/Q2210-IT-ITeS Sector) to achieve the target.	PAC approved the target of 350 candidates for the PIA as per the following trades: (i) Power Distribution Lineman (PSS/Q0102- Power Sector) - 210 Candidates (ii) CRM Domestic Voice (SSC/Q2210- IT-ITeS Sector) - 140 Candidates.

Representation by 2 YP Projects

Representation by two Yearly Plan (YP) Projects	Decision taken by the PAC
<p>i) PIAs Centum Workskills India Ltd & ICA Eductech Pvt Ltd have submitted a request to waive off extension fees to the tune of 5% of Total Project Cost which was imposed as per 03rd PAC meeting.</p>	<p>As per the 3rd PAC decision, five YP projects were given project extension on the condition that a 5% extension fee will be imposed on the total project cost of the respective PIAs. Three YP projects (viz. Quess Corp, Indiacan Education Pvt Ltd, & Wazir Advisors) have already submitted the 5% extension fee. The PAC decided that the two YP projects (viz. Centum Workskills India Ltd & ICA Eductech Pvt Ltd) have to pay 5% of the Project Extension fee as per the 3rd PAC decision with penal interest of 10% per annum.</p>
<p>ii) Centum Workskills India Ltd. has submitted a request to consider placement achievement as on 03-03-2020 i.e. 4277 placed candidates for Project Closure.</p>	<p>The CEO, HSRLM informed the Committee that the project was allotted to the PIA for a period of 3 years (02-10-2014 to 01-10-2017). However, due to non achievement of placement target the PIA made request for extension which was granted by the 3rd PAC on 12th Oct. 2018 for a period of 9 months to place the candidates (12th Oct 2018 to 12th July 2019) on the condition that an extension fee of 5% of project cost for extension will be imposed and the agency has to achieve 70% of placement, else the achievement as on project closure date (i.e 1st Oct 2017) will be considered.</p> <p>PIA requested for 2nd extension, as it could only achieve 58.6% of the placement target. The 4th PAC gave an extension for 6 months (4 Sep 2019 till 3 March 2020) to the PIA. Achievement at the end of 2nd extension i.e. 3rd March 2020 was 4277 candidates placed (59%) of the total target.</p> <p>So the office of CEO, HSRLM issued a notice to the PIA for Project Closure on the terms defined by 3rd PAC. But the PIA went into an appeal to the PS, RD, who considered their appeal & rejected vide order memo no. HSRLM/DDU-GKY/2020/2127 dated 21-07-2020. The office of CEO, HSRLM issued them Show Cause Notice 3 times, but the PIA never responded to the office of HSRLM, but made appeals at different levels.</p> <p style="text-align: center;"><i>afmg.</i></p>



	<p>CEO, HSRLM further informed the Committee that as per SOP of DDU-GKY the PIA has exhausted the opportunity of Appeals. Hence it cannot be reviewed by PAC.</p> <p>The chair was of the view that in light of the MoRD notification no. 8/2020 dated 9 Mar 2020 on "Project Closure and Default Management Procedures" and reference from Government, in this case it may be referred to the State Government for final view.</p>
